SUBJECT: Eight Team Single Elimination Bracket

Note 1: Six pools were established for tournament play. The winner from each pool will be named and the declared team will advance to single elimination bracket play as shown on the official game schedule.

POOL A - POOL B - POOL C - POOL D - POOL E - POOL F (6 teams) ***POOL WINNERS***

The tie-breaker moves from a, b, c, d, e in letter order for declaring the pool winner. See list below!

- (a) Best Record within a Pool!
 - (b) HEAD-TO-HEAD (considered if only two teams have the same pool record)
 - (c) Least runs allowed by totaling all cumulative runs in the three games played by team involved in a tiebreaker.
 - (d) Most runs scored (maximum credit of 10 in any game) by totaling all together in the three games played in pool play. As an example, the most runs scored total could not exceed 10 runs per game X 3 = 30 max)
 - (e) COIN TOSS

Note 2: In addition, (from the eighteen remaining teams) two teams will be declared as “Wild Card” teams.

Two teams will advance from pool play as “Wild Card” teams. Only after the six teams (NOTE #1) are decided and then placed in the bracket will the two “Wild Card” teams be considered. Process will resume.

The tie-breaker moves from “f”, “g”, “h”, “i” in letter order for declaring the “Wild Cards”. See list below!

- (f) BEST OVERALL RECORD (All remaining teams from all pools with same records would be considered)
 - (g) Least runs allowed by totaling all cumulative runs in games played by a team involved in a tiebreaker.
 - (h) Most runs scored (maximum credit of 10 in any game) by totaling all together in the three games played in pool. As an example, the most runs scored total could not exceed 10 runs per game X 3 = 30 max)
 - (i) Coin toss among those remaining after “f”, “g”, “h” are unable to break the remaining ties

Note 3: Placement in the bracket of two Wild Card teams –

- (j) Highest seeded Wild Card team will play TEAM A Pool Winner in Game #1 of Bracket Play
- (k) Second seeded Wild Card team will play TEAM F Pool Winner in Game #4 of Bracket Play

Exception: The Wild Card teams will be reversed if the placement would cause a team to play its’ first game of bracket play against a team from within their same pool!

- (m) Forfeits create an unfortunate situation for all teams as it impacts the tiebreaker procedures. If a forfeit should occur the opposing team would be credited with a 7-0 win.
